Volunteer Application

Here are some facts and guidelines to help you have a productive visit to our Food Bank:

- First and foremost, please know that no matter how small the task seems, the work that you do here is important to our operation. By treating each assigned task with purpose and diligence, you will be greatly increasing the efficiency of the Food Bank, and enabling us to better serve those in need.
- For insurance and safety purposes, children under the age of 18 must be accompanied by a parent or guardian at all times. We require at least 1 adult for every 6 volunteers under age 18. The minimum age for volunteers is 13 years old.
- Prison inmates from a local camp are here to help us each day. Although volunteers will not be working directly with these men, they may be in the vicinity. They are well supervised at all times.
- Volunteers will be provided with cold bottled water.
- The bulk of our volunteer activities involve handling food, so for safety purposes, please refrain from volunteering if you experience any of the following:
 1. Symptoms of a food-borne illness
 2. Respiratory infection
 3. Open or infected cuts on your hands or wrists
 4. Communicable diseases that can be transmitted through the handling of food
 5. Food allergies (please advise so that we can schedule a task)
 6. Latex allergies that would prevent you from wearing gloves while handling product

We'd be happy to reschedule any shift that needs to be cancelled for health and safety concerns!

- Please – dress modestly. No shorts or halter-tops. Volunteers must wear close-toed shoes to protect themselves while in the warehouse. Volunteers who arrive in violation of this dress code will be asked to reschedule their shift.
